Operator's commitments to TREE2MOUTHTM

- 1) Purchase and merchandise TREE2MOUTH complete menu list of core items.
- 2) Purchase all food service items from TREE2MOUTH approved distributor including pulp, cinnaroasted nuts and displays.
- 3) Not to substitute any TREE2MOUTH menu item or recipe with any unauthorized items such as generic fruit cups or any menu item.
- 4) Don't intermingle unauthorized competitive products with TREE2MOUTH products without a written authorization. (For example, bananas are allowed but not any other fruit or pulp.)
- 5) TREE2MOUTH will introduce new items to the menu. You hereby consent to allow TREE2MOUTH to automatically ship one case to your location for the product rollout.
- 6) The Operator him or herself (or an appointed food service manager) shall be responsible for all product availability and core values of TREE2MOUTH brand.
- 7) Utilize TREE2MOUTH online orientation and training. Train current and new employees to ensure continued quality and safety of TREE2MOUTH program.
- 8) All operators and employees view and complete online video training program and pass the required test.
- 9) TREE2MOUTH requires the operator and food handlers to go through online certification or retraining once a year or earlier, if needed.





- 10) Allow TREE2MOUTH representative full access at any time during normal operating hours to the cooler, refrigerator, blender and all related storage and equipment used for TREE2MOUTH operation.
- 11) Maintain the TREE2MOUTH program as specified and mentioned in our initial training session.
- 12) You may discontinue TREE2MOUTH program at any time by providing a written notice to TREE2MOUTH Ambassador or representative for your location.
- 13) Your opening cannot be scheduled until the below listed requirements are completed
 - A) Operator, manager, and employee online training and orientation are completed.
 - B) A pre-opening checklist is completed by TREE2MOUTH Ambassador or representative and verification of the availability of all core items and related items at the location.
- 14) Noncompliance with any of the above may result in mandatory retraining being scheduled, based on trainer's availability. Continued noncompliance may result in termination of your TREE2MOUTH program or loss of geographic protection.
- 15) Give TREE2MOUTH prior written notice in the event an operator either sells or leaves his or her location to another operator.
- 16) In the event that operator is no longer participating in TREE2MOUTH program for any reason, the operator shall remove all signs, graphics, logos, both inside and outside, within 7 days of ending the program.
